RESOLUTION NO. 2020-R-6

A RESOLUTION AUTHORIZING THE TRANSFER OF FUNDS BY THE FISCAL OFFICER FROM THE GENERAL FUND TO OTHER FUND(S) OF THE SUBDIVISION PURSUANT TO SECTION 5705.14(E) OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY

WHEREAS, the Village Fiscal Officer has determined and advised Village Council that it is necessary to transfer money from the General Fund to other fund(s) of the subdivision; and

WHEREAS, no transfer shall be made from one fund of a subdivision to any other fund, except as provided by Section 5705.14 of the Ohio Revised Code; and

WHEREAS, Section 5705.14(E) of the Ohio Revised Code specifically provides that money may be transferred from the general fund to any other fund of the subdivision; and

WHEREAS, money may be transferred from the general fund to any other fund of the village by simple resolution and majority vote of village council. [See Village Officer's Handbook, March 2019, Chapter Three: Administration and Finance, Section II(D)(5)(d) Transfer of funds, General fund (page 3-9); also see Chapter Six: Accounting Procedures, Section V(1), Transfers, (page 6-7)]

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF WAKEMAN, STATE OF OHIO: (RC 731.18)

SECTION 1. That the Village Fiscal Officer is hereby authorized to transfer money from the general fund to another fund of the subdivision as follows:

<u>FROM</u>	<u>TO</u>	<u>AMOUNT</u>
(1000) General	(2131) Police Levy Fund	\$20,000.00

SECTION 2. DISPENSE WITH THREE READINGS. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 3. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this Ordinance is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s): *The immediate effectiveness of this ordinance is necessary to provide the funds required for the continued operations of the Village.*

SECTION 4. PUBLIC MEETING. It is found and determined that all formal action of this public body concerning or relating to the passage of this Resolution/Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any

applicable provisions of Section 121.22 of the Ohio Revised Code.

WHEREFORE, this Ordinance/Resolution shall take effect at the earliest period allowed by law.
